STALLION SERVICE AUCTION DONATION AGREEMENT

The undersigned, stallion owner/agent hereinafter known as Donor, donates, at no cost, to the Paso Fino Horse Association, Inc., 4047 Iron Works Parkway, Suite 1, Lexington KY 40511 hereinafter known as PFHA, one (1) stallion service (breeding) to the stallion listed below for the breeding season(s) (January-December) of the year(s) stated with the authorization signatures. The stallion's service is to be auctioned by PFHA during the corresponding year's Grand National Championship Show and through March 31st of the following year.

This stallion service donation is subject to the following:

1. Stallion must be registered with the PFHA and stallion owner(s)/agent(s) must be a current member(s) in good standing with the PFHA.
2. The stallion service will be auctioned by silent open bidding at the PFHA Grand National Championship Show. The service to any stallion receiving a bid by the stated closing time during the National Show is sold to the highest bidder, and that service is considered sold and not available any more for that year's SSA. All remaining stallions' services will be offered on the PFHA web site and through the Paso Fino Horse World until March 1st of the following year, sold for the first payment in full. The owner of a stallion whose service is purchased as per the above will be ENTITLED TO ONE FREE NOMINATION OF A WEANLING TO THE FABULOUS FUTURITY for that breeding year (a \$75 value). The owner will still be responsible for all remaining fees to the Fabulous Futurity program to maintain the foal's eligibility to that program.
3. ONLY OFFSPRING OF SSA PARTICIPATING STALLIONS WHOSE SERVICES ARE PURCHASED THROUGH THE SSA ARE ELIGIBLE TO PARTICIPATE IN THE BREEDERS' SWEEPSTAKES CLASSES during their yearling year (2 years after the corresponding breeding season). ELIGIBILITY of stallion offspring is attained through the purchase of the stallion's service as per section 2 above or, if a stallion did not receive a bid by March 1, the stallion owner can attain the stallion's offspring eligibility by contributing an eligibility fee of \$200 by March 31. THE STALLION'S ELIGIBILITY ENTITLES DONOR TO ENTER ONE OFFSPRING OF THE DONATED STALLION IN THE BREEDER SWEEPSTAKES CLASS WITHOUT PAYING THE NOMINATION FEE (a \$200 value). Donor will only have to pay the National class entry fee.
4. Donors of stallion services that did not become ELIGIBLE as per section 3 above will be invoiced a \$30.00 fee for advertising and printing cost of the SSA catalog. If a stallion does not become ELIGIBLE as per above for 2 consecutive years, it will be removed from the following year's auction. If the owner wishes to re-enter his stallion to the SSA at a later date, a new donation agreement must be completed.
5. Donor is subject to all the conditions of PFHA Stallion Service Auction Agreement, and the policies and rules governing the Stallion Service Auction and Breeders Sweepstakes.
6. Donor is to provide a copy of the breeding contract file to the PFHA office Attention to the SSA/BS not later than July 30 of the SSA year. The sale of the stallion service (breeding) will be subject to this breeding contract and when signed by Donor and the Bidder becomes a binding contract between Donor and Bidder.
7. Donor will be notified by PFHA within 30 days of the sale of the breeding with the name of the winning bidder.
8. Donor will provide a breeding contract to the winning Bidder. The contract will be binding between Donor and the Bidder to protect both parties from unnecessary expense for either Donor or Bidder.
9. If said breeding purchased through the Stallion Service Auction, for valid reasons does not conclude in a successful breeding, the breeding may be rolled over to the following year with proper notification from bidder to PFHA and approval of the Chair of the PFHA Futurity Committee.
